<p>Q4 Fix Version Reporting JIRA Ticket Updates</p>	<p>Sharon</p>	<p>As the development timeframe of Q4 2019 has closed, we were asked to review and update our JIRA tickets assigned to this quarter. Let's take a look at the updates that were made:</p> <ul style="list-style-type: none"> • Fix Version Updates • Out of scope issues <p>There are a few reports/clusters that were requested but are not possible with just FOLIO data - that is, they include data from outside FOLIO, like ILL or Atlas integrations. We would like to reflect in JIRA that these reports are out of scope and need to be worked on by individual institutions (or groups of institutions) working on those integrations.</p> <p>For "fix versions" (or assigning a FOLIO release date to a JIRA issue), we only have a couple of issues that we can predict the release date. These fix versions are being applied to UXPROD issues, which is where we've been creating our cluster issues. Some of the clusters are out of scope because of a data integration (see above), others just haven't been started yet and can't get a fix version.</p> <ul style="list-style-type: none"> • UXPROD-2049 MM - Collections Analysis Cluster <ul style="list-style-type: none"> • note: MM cluster group has already listed the fields required for this cluster, so might be able to make progress soon • UXPROD-2025 RA-ILL Cluster <ul style="list-style-type: none"> • the reports in this cluster are all out of scope because FOLIO does not contain ILL data. Institutions need to look at these reports themselves • correction: sometimes ILL data is in FOLIO, because the loan is of an institution's item to someone at another institution, and some institutions use patron group to reflect that • these reports may need more information, maybe we should ask RA to provide additional details/specs • we could discuss this at WOLFcon • UXPROD-2030 RA-Reserves Atlas Cluster <ul style="list-style-type: none"> • seems like reports that require Atlas won't be possible • but is there work on doing reserves in FOLIO that would supplant Atlas/Ares? • Index Data may be working on a Reserves module • RA SIG is just starting to see development on Reserves module • Will ask at WOLFcon to try to get more information about what FOLIO is doing with reserves - maybe talk with Kelly Drake from FLO • Reporting SIG members should ask about integrations/reserves at their institutions
